- 1. <u>To receive apologies for absence</u> Apologies were accepted as above
- 2. <u>To receive declarations of interest from Councillors</u> Cllr D Martin non pecuniary
- 3. To consider quotes for the Solar Panels at Jacksdale & Underwood Community Centre
  The Chairman reported that although quotes were considered at the full council meeting on
  27<sup>th</sup> October 2015 the correct procedure was not followed. Cllr J Butler had done nothing
  wrong as he only did what was asked of him but the quotes should have been sent to the Clerk
  in sealed envelopes.

Tonight's meeting is solely to consider the quotes as a decision has already been passed to put the solar panels on Jacksdale & Underwood Community Centres.

The Chairman then passed out a summary of the 4 quotes received which had been opened by the Clerk and Chairman. Cllr Wilson asked if the cost included damage and the Clerk informed the panels were not covered for acts of vandalism and the cost of insurance would be

a maximum of £30 per centre per annum which was shown on the bottom of the summary of quotes.

Cllr S Jackson requested that the voting on the choice of quotes be recorded, ( 3.q of Standing Orders).

After a discussion on the warranties provided by the Solar Panel Companies Cllr C Lewis proposed the cheapest quote of £11138 + VAT for the two community centres which was from Solar, Collective Green Energy Ltd. The proposal was seconded by Cllr A Hankin. Those in favour were Cllr C Quinn-Wilcox, Cllr D Justice, Cllr M Lodge, Cllr D Martin, Cllr G Turner, Cllr M Biggs, Cllr A Hankin, Cllr C Lewis and Cllr R Sears-Piccavey. Those against were Cllr S Jackson, Cllr M Ashmore, Cllr B Jackson, Cllr S Wilson and Cllr S Alvey.

No one raised their hand when the Chairman asked for abstentions.

Therefore the motion was carried to award the contract for solar panels at Jacksdale and Underwood Community Centres to Solar Collective Green Energy.
